

# SOCIAL WORK INNOVATION, EXPERIMENTATION AND RESEARCH CENTER SCHOOL OF ARTS AND SCIENCES, NATIONAL UNIVERSITY OF MONGOLIA

## Background

Social work is a helping profession. The following definition developed by the *International Federation of Social Work General Meeting* and *International Association of Schools of Social Work General Assembly*, approved in 2014, captures this sentiment:

Social work is a practice-based profession and an academic discipline that promotes social change and development, social cohesion, and the empowerment and liberation of people (IFSW & IASSW, 2014).

In 2000, lecturers in the *Department of Sociology* at the *National University of Mongolia* (NUM) established a Bachelor-level program in social work. As a result of the success of this offering, the Department was later re-named as the *Department of Sociology and Social Work* (DSSW). Currently, the DSSW offers social work programs at Bachelor, Master, and Doctoral levels.

Following the introduction of the *Global Standards for Social Work Education and Training* in 2020, social work lecturers in the DSSW at NUM discussed and agreed to the establishment of a social work innovation, experimentation, and research center. The intention of the center would be to develop evidence-based social work education approaches and practices in collaboration with local and international scholars.

The *Social Work Innovation, Experimentation and Research Center* (SWIERC), affiliated with the *School of Arts and Sciences* (SAS) at NUM was officially established by the Rector's order (no A/146) on the 19<sup>th</sup> March 2024, which was designed to coincide with *World Social Work Day*.

#### Aim

The aim of the SWIERC is to meaningfully contribute to the development of social work infrastructure based on social work research, knowledge innovations, and practice. In addition, SWIERC aims to become a national center which is capable of undertaking social research at local, national, regional and international levels.

## **Main activities**

Lecturers and researchers affilitated with SWIERC will carry out research and training based on their specialised fields. These areas are inclusive, but not exhaustive, of:

- Social work;
- Social protection and welfare policy;
- Child protection;
- Disability;
- Inclusive social and education services;
- Gender Equality; and
- Public and Private Partnership.

As a team, the center members will undertake independent and cutting-edge research and training in the fields of fundamental and applied social science and education, specifically in the field of social work. They will also collaborate with professionals and practitioners across the country, region, and world with the same interests to enact research and experimentation to further develop and apply innovative knowledge and practice in the field.
