"Center for Economic and Business Law" is established under the auspicies of School of Law, National University of Mongollia. The Center conducts policy-related, sectoral and interdisciplinary research in economic and business law sectors; organizes training for specialist in commercial law and promotes development of targetted sectors. The center actively includes LLM, PhD students and other researchers in its research teams.

The Center for Economic and Business Law consists of 8 main member, including leacturers, professors and researchers from the School of Law of the National University of Mongolia. Among them, there are 5 lecturers with a doctorate degree and 3 lecturers with a master's degree. Other law school faculty members participate in the center's research on an open basis.
